



Important Information When Joining a KCP Team

Please note: This information applies only to teams Sponsored by KC Premiere. It does not apply to all teams participating in KC Premiere Leagues/Tournaments.

Adidas Sponsorship:

KC Premiere is an adidas sponsored program. All players must wear adidas socks and shoes for all games. No other competitors logos may be worn or visible during games. This is strictly enforced.

We encourage all our fans to show their support of KC Premiere and adidas. KCP branded apparel and accessories will be available via our Online Team Store. Families will be notified of sale dates.

Team Communication:

TeamSnap is used to convey practice / game times, communication from the Coach or Team Director.

LeagueApps is used for billing, general team information from Executive Director/Operations Director.

Cancellations/Inclement weather: if school is not in session, schools are closed. In the event of inclement weather, coaches will be notified and all participants will receive a TeamSnap notification.

Scheduling of KCP Team Activities:

Practice: Teams typically practice twice per week. We try to keep practice schedules consistent. Nights, times and locations may vary depending upon availability of coaches and the facilities.

SSAI: (Speed Strength Agility Intensity) sessions are included in fees and strongly encouraged. KC Premiere is designed for players who are serious about putting in the work needed to develop.

Games: Players should expect to play almost every weekend during a season, except holidays. Not all teams will play in all tourneys but will play the same number of games during the season.

We cannot schedule around individual activities. However, please advise Coach of any player conflicts for the following week including weekend games by noon on the preceding Friday (7 days in advance.) If an event impacts an entire team or Coach is unavailable, the Coach will issue a schedule request.

Other Important Information:

Concussion Protocol: Any contact involving the head will result in immediate removal from the game. If a parent examines the player and feels they can return, they can authorize it by signing the scoresheet.

Insurance: KC Premiere carries both a General Liability and an Accident and Medical Policy to cover anything we are liable for that happens while our coaches and players are in the act of coaching/playing. It is not intended to replace and will not be used to substitute for the primary medical insurance coverage.

Paperwork: Players may not participate in games until all paperwork is submitted. Hard copies only. For the privacy and security of your player, we can not receive emailed / texted versions of documents.

Participation on Outside Teams: Players are not allowed to participate on any other **non-school** team. This would constitute a conflict of interest under our insurance policy and adidas sponsorship agreement.

Payment Methods: Uniform fees must be paid by cash or check. Monthly donations / installments can be paid online via LeagueApps (login located on our website) or payment submitted at any KCP event.

Training: All KCP Coaches are required to complete Child Abuse, Sex Abuse, Concussion, and Crisis Management Training. We are the only youth BB organization in KC that requires this additional training.

- #3** Accept the KC Premiere TeamSnap player invite **WITHIN 24 HOURS of receiving the email**
(If TeamSnap invite is not accepted within 24 hours, player will not be rostered for KCP team)
- #4** Player and parent need to attend the MANDATORY Organizational meeting held each season.
(Players not represented at the meeting will not be allowed to participate for the current season)
- #5** Pick up uniform / purchase a new one if needed, purchase adidas shoes (on own), and pay fees.

- All players must be in adidas shoes and branding at all KCP games (no other logos)**

FINANCIAL AGREEMENT / PARTICIPATION WAIVER / PHOTO RELEASE

Premiere Basketball, Inc. is a state and federal non-profit organization under section 501(c)(3). The team budget is typically upside down at the end of each year. Monthly installments are based on the fixed costs involved in operating the teams for the season, and equally divided into payments over the course of the season.

Players that join a KCP team during the middle of a season (after tryouts have taken place), will be charged starting the month they begin, through the end of the season they join. There is no proration of fees for any month. When a player joins a team, they will be charged for the entire month and season in which they join.

Once a player tries out and is offered a spot on a team, they are committed financially for the duration of the season (fall, winter, spring/summer). The only exceptions where fees will be waived or discontinued is (1) in the event a player is injured while playing for KCP and is unable to participate for period of one month or longer OR (2) a player must leave the team during the season to participate on a school sponsored team provided notice was given at the start of the season.

Uniform Package for 3rd-7th Boys / 3rd-8th Girls (\$100) and includes reversible jersey top (with #) and jersey shorts (with #). Players must purchase adidas shoes. Adidas shoes & socks must be worn at all times for all players of all KCP teams. No competitor logos may be displayed on undershirts, headbands, knee pads etc.

Uniform / player fees are non-refundable and due on designated date. **As of September 1st, 2019, a late fee of \$10 will be assessed to any account not paid within 10 days of the payment due date. Players with past due fees heading into the following month will be unable to participate until fees are paid.**

Limited scholarship assistance is available for families who qualify. Please communicate any special financial circumstances to the Operations Director.

Team Guidelines & Expectations

BAR ONE

Coaches

- Be a positive role model; set the example for other teams playing in our events.
- Avoid receiving technical fouls; show kids how to handle adversity with class.
- Promote sportsmanship by holding players and parents accountable for behavior.
- Provide regular feedback to players on strengths and areas of improvement.
- Arrive to practices 15 minutes early and games 30 minutes early (1 hour early for HS teams).
- Communicate any roster changes (adding/dropping players) with administration.
- Utilize opportunities to equalize playing time over the course of the season.
- Enforce Adidas only uniform protocol for all of your assistant coaches and team members.
- Facilitate collection of paperwork prior to participation and collection of fees according to schedule.
- Prioritize the development of players above winning at all costs.

BAR TWO

Parents

- Be a positive role model; set the example for other fans attending our events.
- Adhere to the KCP Code of Conduct by not saying anything negative to or about officials.
- Demonstrate self control and hold players accountable for their behavior and actions.
- Ensure players have effective time management skills to ensure homework and academics stay #1.
- Coordinate logistics so players are at practice 5-10 minutes early and at games 30-60 minutes early.
- Communicate with your coach directly about scheduling conflicts and special circumstances.
- Avoid approaching your coach about playing time; encourage players to ask their coach what they can do to improve.
- Show your team spirit and appreciation for our sponsor.
- Submit paperwork as requested and player fee donations in a timely manner.
- Support your player by telling them how much you enjoy watching them play.
- Avoid coaching your child from the sidelines, or compare them to other players. Be their biggest fan.

- Be a positive role model; set the example for other players playing in our events.
- Do not react to officiating negatively by saying anything smart or exhibiting bad body language.
- Demonstrate good sportsmanship at all times. Help players up, hold yourself accountable, maintain class.
- Don't text, tweet, or post any unflattering images or sentiments. Have program loyalty to your team and sponsor.
- Be the best student-athlete you can be. Manage your time so homework is done before practice.
- Earn playing time by being coachable, a leader, unselfish, and a good teammate.
- Always be in proper uniform. Do not wear anything to draw unnecessary attention to yourself.
- Reallocate time spent with technology towards studies and improving your basketball skills.
- Make good decisions on and off the court. Be more concerned with your character than reputation.

KCP Sponsored Teams Travel Protocol

Please note: not all teams travel. If a team is invited to travel, you will be notified, and the following guidelines will apply:

Marriott is the official and EXCLUSIVE hotel provider for KC Premiere Basketball. We are required to stay with Marriott.

We get deeply discounted rates and other incentives based on the volume of inbound and outbound business by KCP.

Per our insurance requirements, KCP administration is responsible for booking all team travel with Marriott properties.

The coaches and administration designate which hotel the team will stay at, and all families are obligated to stay there.

KC Premiere will provide the rooming list to the host hotel by cutoff date and secure all rooms with a team credit card.

Families switch the method of payment at check in. This streamlined approach is another reason we get better rates.

We have legally and financially binding contracts with the hotel and cannot cancel rooms without paying for the room.

Additionally, all families must pay for their room (versus using their travel points but can earn points) per the contract.

All team members must stay at the host hotel every night of the stay in order to comply with our liability insurance policy.
